## CONDITIONS

1. The Bank reserves the right to let to renters.
2. The relation between the renter of the safe and the Bank is that of a Lessee and Lessor.
3. The rental of the locker at Rs. Per year shall be payable in advance and no refund will be made if the Lesser vacates the Locker before the expiry of the Lease. In case the Bank requires the Locker to be vacated after due notice, refund will be given for the balance period of whole months.
4. Access to the Vault containing the Safe Deposit Locker may be had between 11 A.M. to 5.00 P.M. on Week days and between 11 A.M. and 1 P.M. on Saturday.
5. The Bank will deliver the only key of the allotted locker to the lessee who must retain it without changing of hands as a prudent men and return the same on he expiry or the term.
6. The Bank will not to examine or certify the contents put in or taken out of the Locker by the lessee but may merely watch.
7. The contents of the Locker being within the knowledge of the lessee, alone, the responsibility of the contents shall be with him the Bank merly guarantees the locker allotted is intact.
8. Access to the Safe Deposit Vault and Locker shall be had by the lessee or in case of joint Lessee by any one of them and in case of death or any joint Lessee by the survivors or survivors of them or by duly appointed Agent of the Lessee or of joint Lessee to gether provided such authority in favour of the Agent is duly recorded see copy in the books of the banks In case of death of sole Lessee or in the case of death of the last surviving Lessee out of Joint Lessee only the legal representative meaning thereby the executor or administrator of a deceased person, shall have access to the Locker.
9. On the day of a termination of the lease, the locker and the key should be handed over to the Bank after removing the contents. In case of failure, the lease of the safe shall be considered renewed after the agreed period until the key anc locker are surrendered to the Bank.
10. The lessee is not to assign or sub let Locker or any parts of it or permit it to be used for any other purpose than the deposit of valuable and other property. The Lessee is not to use the locker for the deposit of any property of explosive or destructive nature.
11. Upon non-payment of rent whether demanded or not or non-observance of any of the above conditions by the lessess, the Lessess shall at the option of the Bank forfeit all rights to the use of the Locker without prejudice to any other remedies with the Bank may have (against him after due notice regarding the payment of rent or prolotionce of any conditions, the Bank is at liberty to break open the Safe and either to forward the contents or the Safe to the lessee to the address given in the memorandum in such manner as may be considered reasonaly safe by the Bank or the contents may be retained in other place of safety at the annual rent to double the amount or renomentioned in the memorandum overleaf and the Lessor shall have a lien a charge upon all properly deposited with them for all rent due form the lessee to lessor with power to sell such property or any part there of for the purpose of realising such rent from time to time
12. Any notice sent by post directed to such address as aforesaid, shall be deemed to have been duly served the bank sould be notified of any change of address.
13. If the key of the Safe is lost by the Lessee, the Bank should be notified without delay but the Bank shall not be responsible for any mistake and charge for opening the safe replacing the lost key and for changing the lock shall be paid by the Lessee.
14. All Repairs necessary to be done to the safe, lock or key shall be done exclusively by workman to be nominated by the Bank.
15. The bank shall have a general line of properly of the Lessee in the safe deposit for all moniea due from the Lessee (with power to realse such property or part there of in satisfaction of monies due but not paid.
16. The Bank reserves the right to change the business hours of the Safe Deposit Department, to amend or add to these rules without notice and for reasons of grave or urgent necessity to close "he safe department for such period as it may deem necessary.
17. The Lessee must be a Saving Bank Account holder of this Bank, with a minimum balance of Rs. 500/- authorising the Bank to debit Hire charges to his account.
18. The Lessee agrees to be bound by the above terms and conditions or those that may be framed by the Bank from time to time in case of any dispute arising between the Bank and the Lessee the same shall be referred to the Register Co-operative Societies, Chhattisgarh or to any person appointed by him and his decision shall be final and binding on both.
